<u>Chief Mulvey</u>: Chief's Report – See full report for details. The following items are noted:

- The Chie's Retreat was a success with hopes to continue with day retreats in the next six months.
- A Draft Budget has been sent to BOT. Currently waiting on PVA Assessments to be released on Wednesday to move forward with Budget planning and finalization before submitting to the BOT.
- The amount of \$2,587.52 has been included in the budget for every employee, as well as an increase for EMT-A from \$2,000 to \$4,000 and for EMT-Paramedics from \$4,000 to \$8,000, and six new positions for future staffing needs.
- Infrastructure needs have been assessed and there will be upcoming requests for generators for Stations which will likely be Capital Expense, not from Reserve Accounts.
- An Information sheet has been prepared, will be kept up-to-date, and will be made available on the website, OneDrive, etc. This is a one-page breakdown of costs for different types of apparatus, ambulance, and turnout gear.
- OSHA has extended its public comment portal for 90 days.
