Old Business

Update on Phase 1 of the St. #73 expansion (former Highview #73 on Cedar Creek Road). Phase 2 has begun with the preparation of HVAC and electrical bid packages.

James Sebastian reported that 90% of the surplus jaws and fans have been sold and picked up for a total of approximately \$2,200. The remaining items will be donated to departments in need.

Jen Crawford reported that she, along with Board Members Deloch and Pierce, reviewed 2 applications for the Scholarship and recommends that the Scholarship be awarded to McKenzie Brown.

Motion Deloch, 2nd Ash to award the Scholarship to McKenzie Brown. MC unanimously.

James Sebastian reported that the repaired Braun ambulance is expected to be delivered in July, along with the two ambulances that have been on order.

Property Owner Trustee Election will be held June 22, 2024 at 11:00 a.m. to 2 p.m. at St. #61.

Notice was received for the appointment by Mayor Greenberg of Robert Thompson to the FC Board of Trustees effective July 1, 2024. (The appointment will be up for approval by the Government Oversight and Audit Committee on June 11 and then proceed to Metro Council).

Motion Pierce, 2^{nd} Ash that the 2024-25 pay increases will take effect on July 7, 2024. MC unanimously.

The performance schedule for the Chief and Deputy Chiefs will be reviewed in December.

Motion Bauer, 2^{nd} Deloch to add the Chief and Deputy Chiefs back to payscale for cost of living and longevity increases. MC unanimously.

Motion Ash, 2nd Pierce to retroactively give the Chief and Deputy Chiefs the 5% increase that was given to all employees, except for them, in July 2023 and the 3% COLA that was given to all employees, except for them, in January 2024. MC unanimously.

- Attorney Leach is handling all correspondence with Fern Creek resident who has lawsuit against his homeowner insurance. (FCFPD is not named in the suit).

Motion Bauer, 2^{nd} Ash to approve an eighteen (18) cent per \$100 tax rate for all taxes, including but not limited to real, personal, tangible, motor vehicle, watercraft, inventory, and aircraft. MC unanimously.

At 7:28 p.m. BOT Brown joined the meeting by audio and it was stated that he will not be eligible to vote on any motions due to the unavailability of video for him.

Deputy Chief Evans presented the 10-Year Fire Apparatus and Ambulance Replacement Plans.

Motion Ash, 2nd Bauer to purchase one refurbished ambulance (18-month to two-year turn-around time), one new ambulance (four-year turn-around time), and one engine for St. #73 (four-year turn-around time) to be purchased through either HGAC or Sourcewell with no bid needed. MC unanimously. (It is noted that BOT Brown was not eligible and therefore did not vote).

Motion Ash, 2nd Pierce to approve the 2023-24 Budget Revisions. MC unanimously. (It is noted that BOT Brown was not eligible and therefore did not vote).

Chairman Ott requested that Ms. Crawford and BOT Deloch meet to develop a plan for recruitment and retention as discussed and present their plan at the July meeting.

Discussion held regarding paperwork and procedures for the upcoming election.
